

Secession and the Civil War, however, led him to expand presidential power in ways that, over time, transformed American society. Among the topics covered are civil liberties during wartime; presidential pardons; the law and Lincolnâ TMs decision-making process; Lincolnâ TMs political ideology and its influence on his approach to citizenship; Lincolnâ ™s defense of the Constitution, the Union, and popular government; constitutional restraints on Lincoln as he dealt with slavery and emancipation; the Lieber codes, which set forth how the military should deal with civilians and with prisoners of war; the loyalty (or treason) of government employees, including Lincolnâ ™s domestic staff; and how Lincolnâ TMs image has been used in presidential rhetoric. Although varied in their strategies and methodologies, these essays expand the understanding of Lincolnâ ™s vision for a united nation grounded in the Constitution.
